

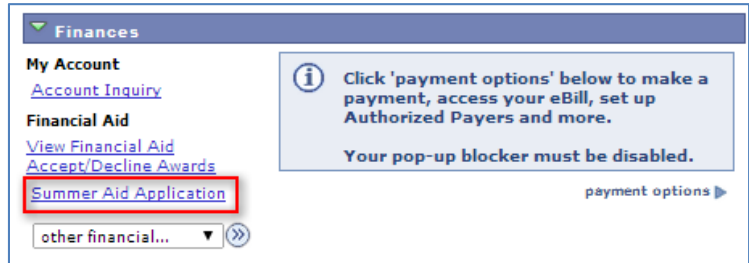


# Using the Student Center: Complete a Summer Financial Aid Application

The Student Center is a self-service page that provides students an entry to the HUB. Along with MyUB, it provides navigation to tools and information that are important to you. To reach the Student Center click the Student Center tab from MyUB. In this tutorial we will review how to submit a Summer Financial Aid Application using the HUB Student Center.

In the Finances group box, under the Financial Aid heading, select the Summer Aid Application link.

Use the Summer Aid page to complete the electronic Summer Aid Application.

**INSTRUCTIONS:**

You must complete the FAFSA and register for all of your summer courses before you submit this application. You can only submit one electronic Summer Aid Application.

**Students are not eligible for financial aid during periods of non-enrollment.**

- If you are enrolled in less than 6 credit hours, you are not eligible for a federal student loan or TAP grant.
  - Before applying for a Summer TAP grant, please schedule an appointment with your financial aid advisor to discuss how this may affect future TAP payments.
  - A summer aid application is not required for Pell only. However, if you do not fill out the summer aid application, your Pell grant will not be packaged until on or after [blank]. If you would like your Pell grant packaged prior to [blank], fill out this application and answer 'no' to the loan questions below.
  - Pell eligibility will be based on the EFC and summer enrollment of at least 3 credit hours.
  - To apply for a Parent PLUS or a Grad PLUS loan, the student will need to submit this Summer Aid Application, then proceed to: [studentloans.gov](http://studentloans.gov) to start the PLUS loan application, Promissory Note and Entrance Counseling.

The University at Buffalo will package you with your summer aid eligibility. Once you have received notification to visit the HUB Student center regarding your summer Financial Aid, you can accept and/or decline loan funds (refer to HUB How To's: Accept/Decline Financial Aid Awards at <http://www.buffalo.edu/hub> ).

Grants and scholarships will automatically be processed for you, based upon eligibility.

You can only submit one Summer Aid Application. You may visit the HUB Student Center, Summer Aid Application page to review your responses to each section.

If you need to make a change to what you have accepted or declined, please schedule an appointment with a Financial Aid advisor. During that appointment, you may be required to complete a Direct Loan Revision Request.
